CALL TO ORDER

Commissioner Baker called the meeting to order.

MODIFICATION(S) TO THE AGENDA

There were no modifications to the agenda.

ADOPTION OF THE AGENDA

The motion was made by Commissioner Sharpe and duly seconded by Commissioner Conti to adopt the Agenda as presented.

The motion passed unanimously.

CEREMONIES

Recognition ceremony for Darcy Kennedy, Administrative Services Division Manager, of the Community Resources Department after 28 years of dedicated service to Arapahoe County.

The motion to adopt the retirement resolution for Darcy Kennedy was made by Commissioner Jackson, duly seconded by Commissioner Sharpe.

Douglas Gerlock thanked supervisor Erika West of the Motor Vehicle Division for her assistance. Mr. Gerlock expressed concern regarding the Aurora police department and the Arapahoe County Sheriff's Office.

The motion was made by Commissioner Jackson, duly seconded by Commissioner Holen to approve the consent agenda as presented.

GENERAL BUSINESS ITEMS

7.a. Resolution No. 190347 - Adoption of IDDE Updated Ordinance

Robert Hill, Senior Assistant County Attorney, established jurisdiction for the Board to consider this ordinance. He confirmed that the ordinance was read in full at the May 28, 2019 public hearing and published in The Villager newspaper. He clarified that the effective date is 30 days after today's public hearing.

Chuck Haskins, Engineering Services Division Manager, explained that his presentation would cover Agenda Item 7.a. and 7.b. A PowerPoint presentation was reviewed. The proposed changes were discussed.

Commissioner Holen acknowledged staff's hard work and the collaboration with SEMSWA (South East Metro Storm Water Authority).

The motion was made by Commissioner Baker, duly seconded by Commissioner Holen to adopt Arapahoe County Ordinance Number 2019-02 on today's date.

7.b. Resolution Nos. 190348-190351 - MS4 Permit Changes Water Quality

Robert Hill, Senior Assistant County Attorney, established jurisdiction for the Board to consider this ordinance.

The public hearing period was opened.

The public hearing period was closed.

The following motion was made by Commissioner Sharpe, duly seconded by Commissioner Conti: In the case of E19-044 – Changes to Engineering Requirements Related to the December 1, 2016 CDPHE MS4 Permit – Enforcement Response Plan, I am in agreement with Staff recommendations as set forth in the Board Summary Report dated June 13, 2019, and hereby move to adopt the Enforcement Response Plan with the following two (2) conditions of approval:

1. Staff is authorized to make modifications to the text as are required to correct minor textual errors in the Plan, and as necessary to update the Plan to reflect subsequent and duly adopted changes or amendments to the enforcement laws, procedures or regulations identified in the Plan.
2. The Enforcement Response Plan will be effective July 1, 2019.

The motion passed unanimously.

The following motion was made by Commissioner Conti, duly seconded by Commissioner Sharpe: In the case of E19-044 – Changes to Engineering Requirements Related to the December 1, 2016 CDPHE MS4 Permit – Stormwater Management Manual, I am in agreement with Staff recommendations as set forth in the Board Summary Report dated June 13, 2019, and hereby move to adopt the proposed Chapter 14 amendment to Stormwater Management Manual, with the following two (2) conditions of approval:

1. Staff is authorized to make modifications to the text as are required to correct minor textual errors in the Plan prior to incorporation into the Stormwater Management Manual.
2. The Stormwater Management Manual will be effective July 1, 2019.

The motion passed unanimously.

The following motion was made by Commissioner Baker, duly seconded by Commissioner Holen: In the case of E19-044 – Changes to Engineering Requirements Related to the December 1, 2016 CDPHE MS4 Permit – Grading Erosion and Sediment Control Manual I am in agreement with Staff recommendations as set forth in the Board Summary Report dated June 13, 2019, and hereby move to adopt the proposed amendment to Grading Erosion and Sediment Control Manual, with the following two (2) conditions of approval:

1. Staff is authorized to make modifications to the text as are required to correct minor textual errors in the proposed Grading Erosion and Sediment Control Manual amendment.
2. The amended Grading Erosion and Sediment Control Manual will be effective July 1, 2019.

The motion passed unanimously.

The following motion was made by Commissioner Sharpe, duly seconded by Commissioner Jackson: In the case of E19-044 – Changes to Engineering Requirements Related to the December 1, 2016 CDPHE MS4 Permit – Stormwater Facility Maintenance Agreement, I am in agreement with Staff recommendations as set forth in the Board Summary Report dated June 13, 2019, and hereby move to adopt the form of the Stormwater Facility Maintenance Agreement for use as applicable for land use development projects within unincorporated Arapahoe County.

The motion passed unanimously.

COMMISSIONER COMMENTS

Commissioner Baker commented on National Elder Abuse Awareness Month and urged people to report any abuse or neglect of older adults. He also discussed the Walk to End Alzheimer's in September and encouraged participation.

Commissioner Holen commented on the importance of Alzheimer's research.

Commissioner Conti mentioned a fascinating presentation on Alzheimer's research by CU Anschutz.

There being no other business before the Board, Commissioner Baker adjourned the meeting at 10:20 a.m.
