**Littleton, Colo** –The following dropoff locations are available to Arapahoe County registered voters who will be dropping off their ballots. All registered voters should receive their ballot by Oct. 20. If you have not received your ballot by that date, please contact the Elections Division at 303-795-4511 to determine the status of your ballot.

The Clerk and Recorder's Office is working in conjunction with the US Postal Service to ensure voters receive their ballots in a timely manner. Please note that ballots returned by mail to the Clerk and Recorder's Office require 60 cent postage. Voters also may deliver ballots to one of the following drop-off locations:
