**METHAMPHETEMINE LAB DISCOVERED**

During the past two weeks, the Arapahoe County Sheriff's Office Patrol Impact Team conducted an investigation into possible drug activity at 19548 East Maplewood Place, City of Centennial. On August 28, 2004, during a surveillance, the resident of the East Maplewood Place address was contacted and found to be in possession of drug paraphernalia, as well as less than one gram of methamphetamine. The suspect is identified as:

**Marcus Love Mccanna**  
**Age 23**  
**19548 East Maplewood Place**  
**Centennial, Colorado**

During the contact, Mccanna told Deputies that he was storing chemicals used to manufacture methamphetamine at the Maplewood Place address. A consent search of the home was conducted and a clandestine methamphetamine laboratory was discovered in the basement of the home. The home was evacuated and secured. Members of the South Metro Drug Task Force and the Cunningham Fire/ Hazmat were called. A unified incident command was established and the drug task force clandestine laboratory response team dismantled the laboratory.

Mccanna is being held at the Arapahoe County Sheriff's Office Detentions Facility on a \$10,000.00 bond. Mccanna will be charged with violations of:

**C.R.S. 18-18-405 Unlawful Manufacture Of A Controlled Substance**, a class 3 Felony.

**C.R.S. 18-18-405 Unlawful possession of a controlled substance**, a class 4 Felony.

During the investigation, Sheriff's Deputies contacted six other individuals, who were found to be wanted on a variety of arrest warrants. Those arrested were identified as:
