CAR JACKING SUSPECT FROM KANSAS TAKEN INTO CUSTODY

On October 13, 2005 at 12:02 P.M. the Arapahoe County Sheriff's Office Communication Center received a report of a theft of gasoline from the:

**Deertrail Texaco
555 East 7th Avenue
Deertrail, Colorado**

The suspect and vehicle, a white 1991 Ford Probe, were observed fleeing westbound on Interstate 70 from the Town of Deertrail.

As sheriff's deputies positioned themselves along I-70, the sheriff's communications center conducted a wants and warrants check on the vehicle's license plate. The vehicle was reported as stolen in a car-jacking incident from the Town of Shawnee, Johnson County, Kansas.

At 12:09 PM ACSO Deputies observed the stolen vehicle traveling westbound on Interstate 70 at mile marker 313 and attempted to stop it. Initially, the vehicle failed to yield to deputies, but eventually stopped at mile marker 312. The driver, identified as:

was taken into custody without incident.

Dilley is being held at the Arapahoe County Detentions Facility on a \$50,000 bond for violations of:

18-4-418 C.R.S., Fuel Piracy, a class 3 Misdemeanor.

A Class 3 Misdemeanor is punishable, upon conviction, by a fine of \$50 to incarceration within the County Jail for 6 months.

42-4-1409 C.R.S., No Proof of Insurance, a Class 1 Traffic Misdemeanor.

A Class 1 Traffic Misdemeanor is punishable, upon conviction, by a fine of \$100 to \$1,000 and incarceration within the County Jail for 10 days to one year.

42-4-1413 C.R.S., Eluding a Peace Officer, a Class 2 Traffic Misdemeanor

A Class 2 Traffic Misdemeanor is punishable, upon conviction, by a fine of \$10-300 and incarceration within the County Jail for 10-90 days.

42-4-1101 C.R.S., Speeding, a Class A Traffic Infraction

A Class A Traffic Infraction is punishable, upon conviction, by a fine of \$15-300

Arapahoe County Sheriff's Office Investigators requested and were granted an enhanced bond of \$50,000 on these misdemeanor charges.

In addition, Johnson County, Kansas issued a no bond Robbery Warrant hold for Dilley.
